

# \$250 Gift Card Promotion 2023

#### **Terms & Conditions**

The Promoter is SKOPE Finance Limited, 57 Princess Street, Riccarton, Christchurch 8041, New Zealand (Postal Address: PO Box 1091).

- 1. Information and instructions about this promotion form part of these Terms and Conditions. By participating in this promotion, the claimant will be deemed to have accepted these Terms and Conditions and agreed to be contractually bound by them.
- 2. Promotion only open to Australian and New Zealand Residents aged 18 years or over.
- 3.
